WHEREAS, THE OLD BRIDGE MUNICIPAL UTILITIES AUTHORITY (the "Authority") desires to make application to the Local Finance Board for its review of a proposed project financing in connection with the undertaking of various water and sewer improvements, including rehabilitating the Perrine Road storage tank, upgrade to supervisory control and data acquisition system (SCADA) system, construction of the Laurence Harbor bulkhead and construction of the Crossroads Regional Interceptor project (supplemental loan) in connection with a loan through the New Jersey Environmental Infrastructure Trust; and

WHEREAS, THE OLD BRIDGE MUNICIPAL UTILITIES AUTHORITY believes that:

- (a) it is in the public interest to accomplish such purposes,
- (b) said purposes or improvements are for the health, welfare, convenience or betterment of the inhabitants of the local unit or units,
- (c) the amounts to be expended for said purposes or improvements are not unreasonable or exorbitant,
- (d) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the local unit or units and such purposes or improvements will not cause any undue financial burden to be placed upon the local unit or units,



and as provided in connection with its loan through the New Jersey Environmental Infrastructure Trust.

**WHEREAS**, this change is a result of additional construction which will consist of field changes to install a fifteen-inch (15") PVC sewer main by means of an "open-cut" method between manholes No. 7 and No. 8 (Oasis Ford parking lot near Rt.18) and between manholes No. 3 and No. 4 (in Spring Valley Road near Luk Oil gas station).; and

**WHEREAS**, This change order also eliminates the tunneling cost in the contract for these lengths of sewer main installation, and covers the claims of the Contractor of unforeseen soil conditions that caused the failure of the tunneling installation; and

**WHEREAS**, these modifications result in a (9.43%) increase to the contract price of \$718,137.00, from an amended total contract amount of \$7,614,649.76 to a new contract amount of \$8,332,786.76; and


**WHEREAS**, total change orders to date represent a 18.74% increase from the original contract amount; and

**WHEREAS**, the Staff Engineer and Consulting Engineer have reviewed the request and reports submitted and have recommended Change Order #7 to Contract #2011-2 in the amount of \$718,137.00 be approved;

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of the Old Bridge Municipal Utilities Authority ("OBMUA") that Change Order #7 in the amount of \$718,137.00 in connection with the Crossroads Regional Interceptor Project (Contract #2011-2) be and the same is hereby approved subject to further approval of the New Jersey Department of Environmental Protection;

**BE IT FURTHER RESOLVED** this resolution ratifies action taken by the Authority on June 17, 2015
