Engineering Reports: Michael Roy, P.E.

1. Rt. 18 Marketplace, W10-612, S10-480, Developer Agreements.

Mr. Roy reported that the Water and Sewer Developer Agreements for the referenced applications have been prepared and signed in accordance with the Final Water and Sewer Approvals granted on October 13, 2010.

The Developer Agreements consist of the standard language and the conditions of the Final Water and Sewer approvals to construct approximately 830 LF of eight and ten inch (8" and 10") water main to connect into an existing water main in Maple Street to service a 10,800 SF retail center located on the southbound side of Rt. 18 at Maple Street north of Wawa. The agreements have been signed by the Developer and are ready to be considered for authorization to be countersigned by the Authority.

A motion was made to approve as recommended Rt. 18 Marketplace Developer Agreements for Water Application No. W10-612 and Sewer Application No. S10-480 by Mr. Smolney and seconded by Mr. Donatelli.

2. Perrine Road Professional Group, W209-604, Bond Release.

Mr. Roy reported that all work has been performed, water meters have been installed, and the utilities will remain privately owned. Based on the current status of this application, the recommendation is to release the Water Performance Guarantee conditioned upon the applicant "zeroing out" the water escrow account.

3 and 4. Commerce Bank, Rt. 9, W204-541, S204-424 Bond Releases and Commerce Bank, Rt. 516, W200-482, S200-372, Bond Releases.

Mr. Roy reported that both these banks have water and sewer lines which will be privately owned and maintained by the commercial property. His recommendation is to release the water and sewer bonds on the two Commerce Banks located on Rt. 516 and Rt. 9. All work has been completed; meters have been installed; as-builts have been completed; and the utilities will be maintained by the commercial property requiring no maintenance bond.

A motion to release as recommended the water and sewer performance guarantees for the Commerce Bank, Rt. 9 Water Application W204-541 and Sewer Application S204-424 and for Commerce Bank, Rt. 516 Water Application W200-482 and Sewer Application S200-372 was made by Mr. Testino and seconded by Mr. Desai.

5. Browntown Plant Painting, Engineering Design Services to CME

Mr. Roy reported that this is a proposal for repainting the Browntown Plant facilities. The paint used on the clarifier which was constructed in the mid '80's is peeling and rusted.

CME Associates retained Tank Industry Consultants to perform a dry evaluation of the clarifier and two water storage tanks at the Browntown Water Treatment plant. The rehabilitative work includes sandblasting and repainting the steel structures.

There is a proposal from CME to prepare the plans and specifications to put this work out to bid. The recommendation is to authorize the work The engineering fees are included in this year's budget; the construction costs of the project will be incorporated into the general fund for next year's budget which includes the repainting of the back storage tank, the suction tank, the clarifier, the backwash holding tank and the exterior piping and the chemical building. The cost of the design phase is \$89,501; the bid phase is \$8,939.

Mr. Testino inquired about the magnitude of the painting.

Mr. Roy responded that this will be determined during the design phase, although it could be a very large range. Painting is not inexpensive; it could be in the millions of dollars. We will attempt to put the money into next year's budget in the general fund. If not, perhaps bonding may be considered.

Mr. Testino asked if phasing the work would be possible.

Executive Director Donatelli responded that an attempt is being made to minimize the scope of the project. Some tanks are in

worse shape than others. Most of the tanks are metal and will have to be contained because of the lead content.

A motion was made to authorize as recommended CME to proceed with engineering design services for the Browntown Plant painting by Mr. Donatelli and seconded by Mr. Smolney.

Old Business:

Recharge Basin Study – Status

Mr. McClelland stated that upon visiting the DEP in Trenton, the Recharge basin study was favorably received, and the DEP provided guidance on the construction of the three recharge basins. A list of required permits was provided by the DEP. It was indicated that there will be challenges in obtaining the necessary permits, but he is optimistic from the discussions which took place. One of the discussions centered upon monitoring wells via tubes being constructed into the soil to monitor groundwater.

There is a requirement that allows water purveyors to obtain credits by recharge. That is the section under which the Authority will qualify based on limitations and conditions. He was encouraged by the discussion.

Mr. McClelland's recommendation is for the Authority to pursue this project.

Mr. Roy added that the monitoring well system will require additional wells to be installed. We will have a meeting with the New Jersey Geologic Survey to determine what data exists and whether there are existing wells that may be utilized because a minimum of one year of historical data is required. There will be a proposal in January for additional monitoring wells which need to be installed to collect the necessary data.

Mr. Testino inquired if these wells would be permanent.

Mr. McClelland stated that although these plastic tube wells are semi-permanent, they are required to be abandoned if you go through with the project.

Mr. Greene asked what the testing would reveal.

Mr. McClelland responded that they will be looking for the location of the natural groundwater. There is a line on the property indicating where the out-crop is and where the soil is more dense (clay).

Crossroads Regional Interceptor – Status

Mr. Roy stated that there are two issues for open session: First, a public hearing is scheduled on December 20, 2010 at 6:00 p.m. wherein R3M will present a power point presentation of the Crossroads Regional Interceptor. The Commissioners are not

required to attend this meeting. The DEP also asked that information on the Summerfield Sewer Replacement project be included.

The second matter is that the DEP is requiring a Cultural Resource Survey which includes investigating any historical or cultural issues which may be disturbed the Crossroads Regional Interceptor project. The cost of the survey will be approximately an additional \$19,000 to R3M Engineering.

A motion was made to authorize as recommended R3M to perform a Cultural Resource Survey at an additional cost of \$19,000 in connection with the Crossroads Regional Interceptor by Mr. Smolney and seconded by Mr. Butler.

There is also a request for an advanced retainer of \$3,000 (the full amount of the retainer being \$6,000).
