**WHEREAS,** MWC has filed a petition with the New Jersey Board of Public Utilities (NJBPU) dated May 20, 2021 for a stated 52% rate increase; and

**WHEREAS**, the OBMUA desires to intervene in the matter of MWC's stated 52% rate increase petition; and

**WHEREAS**, the Township has awarded a contract pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11) for expert utility rate analysis professional services; and

**WHEREAS**, the OBMUA is in need of professional services and/or legal and expert utility rate analysis in support of its intervention in the matter of Middlesex Board of Public Utilities Rate Increase Petition dated May 20, 2021; and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., (the "Act") permits units of local government to share services for particular purposes and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

**WHEREAS**, the Township and the OBMUA are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Services Agreement pursuant to the Act; and

**WHEREAS**, the Township and the OBMUA have negotiated the terms of a Shared Services Agreement, included as EXHIBIT A and incorporated into this Resolution as if set forth at length herein; and

WHEREAS, the Executive Director and Authority Engineer have recommended the proposed agreement as representing the best value for OBMUA rate payees; and

**WHEREAS**, the Commissioners of the OBMUA have indicated their desire to accept the recommendation of the Executive Director and Authority Engineer; and

**NOW, THEREFORE, BE IT RESOLVED** by the Commissioners of the Old Bridge Municipal Utilities Authority ("OBMUA") that the Executive Director be and the same are hereby authorized to execute the Shared Services Agreement in accordance with its terms;

WHEREAS, CME Associates has recommended that the contracted be awarded to Lucas Brothers, Inc., 80 Amboy Road, Morganville, NJ 07751; and
