Notice is hereby given that sealed bids will be received by the Old Bridge Municipal Utilities Authority, for the Matawan Road Sewer Replacement, Contract No. 2023-3, and will be opened and read in public at the Authority's Engineer's Office, 15 Throckmorton Lane, Old Bridge, New Jersey 08857 on **Tuesday, June 4, 2024 at 2:00 P.M.**, prevailing time.

Bids must be made on the standard Proposal form in the manner designated therein and must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the project on the outside, addressed to the Old Bridge Municipal Utilities Authority, and must be accompanied by Certified Check, Bid Bond or Cashier's Check drawn to the order of the Old Bridge Municipal Utilities Authority for ten percent (10%) of the total amount bid, provided said security need not be more than \$20,000.00. All bid guarantees shall be accompanied by an executed consent from an approved surety company, licensed to conduct business in the State of New Jersey, agreeing to fu

rnish the required Performance and Maintenance Bond upon the award of contract.

All other bid securities will be returned within three days after awarding and signing of the contract and approval of the Contractor's Performance Bond, Saturdays, Sundays, and Holidays excepted.
